- Please <u>check</u> whether your company have participated in any trade fairs/events and is registered under the said address above to avoid unexpected penalty/ies.
- The said registration is good for <u>one (1) year</u> and needs to close the registration by <u>the owner</u> or any <u>authorized representative</u> at the end of the year to avoid penalty fees. **OR** if you are planning to participate again in any trade fairs/events under the said address, renew the registration <u>on or before January 31</u> of the <u>succeeding year</u>.
