## PARTICIPATION IN IFEX PHILIPPINES

Together with this Space Application Form, the Application and Acceptance Procedures, the IFEX Philippines Exhibitor Manual, and IFEX Philippines Table of Violations and Sanctions shall form part of the documentation to exhibit in IFEX Philippines.

#### PAYMENTS

A "NO FULL PAYMENT, NO PARTICIPATION" policy shall be strictly implemented. Exhibitors with pending accounts with CITEM shall not be allowed to join IFEX Philippines.

## **DEADLINES**

Full Participation Fee must be paid no later than 90 days before event date.

## ATTENDANCE TO BRIEFINGS AND EXPORT COACHING PROGRAMS

Exhibitors must be responsible in sending at least one (1) company representative, preferably owner or decision maker, to exhibitor briefings and seminars/meetings required by CITEM. Export Coaching Program and Design for Exports Food Program are subject to an acceptance criteria of the consultant.

Products displayed in the booth are all labeled in the name of the exhibitor. Exhibitors are strictly prohibited to share their booths/spaces to their sub-contractors nor to accommodate / display the products of subcontractors in their booth.

## WITHDRAWAL FROM PARTICIPATION

Once an application has been accepted, withdrawal may still be allowed 45 days before event date only. After such period, cancellation may be allowed, however, payments made shall be forfeited in favor of CITEM.

## THIRD PARTY CLAIMS

The Exhibitor shall hold CITEM free from any third party claim/liability arising from his/her participation in the show, the products exhibited, or acts/deeds committed by the exhibitor or his/her employees or agents.

## RESOLUTION OF CONFLICT & DISAGREEMENT
